Additional Benefits of the Indy Rotary Corporate Connection.

- **Member Spotlight table.** Promote your service or business with a table of marketing materials or a display. (space and size of table or display, subject to review by Rotary).

Pricing

There is a one time corporate initiation fee of **\$1,200** plus semi-annual dues of *\$253.00 (beginning July 1, 2014) for each member. The Rotary Club of Indianapolis will prorate dues if members join before or after the fiscal year, which runs July 1 to June 30.

Dues and Fees: Defined

About dues in general. Applies to all Rotarians.

- New member applications are reviewed by the Membership committee once per month. They are also reviewed by the Officers and Board of Directors before approving for membership.
- All members, individual or corporate, new or current, pay the same amount in dues.
- Currently (July 1, 2014 to June 30, 2015) dues are \$253 semi-annually.
- Our fiscal year begins July 1, each year. Dues periods are July 1 to December 31. And, January 1 to June 30. Dues rates increase slightly every July.

Description of Corporate Memberships for new members and the current "Corporate Membership Special."

- Our Corporate initiation fees are \$1,200.00.
- Our current special discount, until December 31, 2014 is half of that initiation fee, or \$600 if joining as a corporate member.
- To qualify as a corporate member, the Rotary Club of Indianapolis requires applications from two individuals representing the corporation, joining the club and each paying regular dues.
- We pro-rate dues if the new member begins in the middle of a dues cycle. For example (using the current dues rates), if a new member were to be approved in October (application received in September, 2014), the dues would be \$126 (\$42 per month for 3 months; Oct, Nov, Dec. x 3 = \$126) plus the initiation. \$126 + \$300 (\$426) for one member and \$126 + \$300 (\$426) for the second member.
- With the corporate membership the corporation / organization also receives a benefits package. A PDF of the benefits can also be downloaded, here: <http://indyrotary.com/071013wp/wp-content/uploads/2014/07/Corporate-Membership-7-21-14.pdf>, and can be found on the reverse side of this flyer.
- Once approved, we schedule a time to meet with the new corporate members to outline the benefits, scheduling and the collection of materials for corporate benefit promotions.
